GENERAL PUBLIC SPEAKS

There were no members present who had questions or wished to speak.

MEMBERS PRESENT

A total of ten (10) members were present, including all seven (7) Directors, and three (3) additional members: Mr. Robert E Rossman, Diane Rowe, and Corey Wilson. Also in attendance was Office Manager Tracy Hasting, and Senior Field Operator Billy McMillan.

QUORUM PRESENT

Mr. Barr declared there to be a quorum present as per the Corporation Bylaws Article 6, section 4.

MINUTES

Copies of the minutes from the December 1, 2020 Annual Membership Meeting were made available to the membership in a packet prior to the meeting. A motion was made by Bill Shanholtz to approve the minutes as written, seconded by Roger Goodsell. There were no additions, corrections, or oppositions, and the minutes were approved as written.

ANNUAL REPORTS

PRESIDENT'S REPORT

Mr. Barr reported that our corporation gained 26 new members in 2020 and collected \$6,600.00 in Equity Buy-In Fees. He explained that Equity Buy-In Fees were added to the cost of a new meter purchase in the July 2020 Director's meeting by a majority vote. Mr. Barr stated that the purpose of the fee is for new members to reimburse the system for past investments to the system's capacity and to create a dedicated fund for future capacity improvements such as line upgrades, new tanks, treatment, or production.

REPORT OF SYSTEM FINANCES

Mr. Barr reported that Dean Water Supply Corporation had a combined total of \$1,110,782.67 in all bank accounts. He further commented that copies of the 2020 Corporation Balance Sheet and Income Statement were provided to the membership prior to the meeting.

OPERATOR'S REPORT

Billy McMillan reported the completion of the line upgrade to a 6" main on CR 1111 to CR 1145, and an upgrade to a 3" main on the West side of 13 Club Lake. The operators also completed several water main repairs, valve replacements, new valve installations and 26 new meter sets and meter upgrades in 2020.

REGULATORY REPORT

Diane Rowe reported that all violations received during the 2019 TCEQ Investigation have been corrected, but no letter to lift the violations had been received from the regional office at the time of the meeting. Billy McMillan stated that Kevin Glanton, TCEQ Region 5 Investigator, will likely revisit us later this year and lift those violations at that time.

RESOLUTION DECLARING UPOPPOSED CANDIDATES

All three candidates up for re-election ran unopposed. A resolution was read into record declaring Bonnie Brooks, Roger Goodsell, and Hayden Moore to be elected Directors of the Dean Water Supply Corporation for another three-year term pursuant to the Texas Water Code Section 67.0055. A motion was made by Sheila Hartsfield and seconded by Kirk Story to accept the resolution as read. No one was opposed, and the motion carried.
